How Women's Savings Groups Are Pioneering Financial Inclusion

In Burkina Faso's rural regions, women's savings groups are rewriting the rules of economic participation with a revolutionary digital credit platform. Spearheaded by RCPB, CIF, and IIDIA, this initiative replaces cumbersome paper ledgers with an intuitive digital system, slashing administrative burdens and unlocking hours for income-generating activities. At its core? A community-first approach, where local facilitators bridge the digital divide through tailored training.

This isn't just about technology, it's about time, trust, and transformation. This intervention not only provides women with financial access but also the freedom to lead.

On World Health Day, IIDiA joined the global call to action under the theme "Healthy Beginnings, Hopeful Futures", championing digital innovation to transform maternal and newborn health. From telemedicine in Rwanda (Babyl) to mobile education tools in South Africa (MomConnect), technology is breaking barriers to care.

We spotlight four game-changing approaches:

- Telemedicine for remote prenatal monitoring.
- Mobile apps delivering life-saving health information.
- Digital ID systems streamlining access to care (e.g., Côte d'Ivoire's ONECI).
- Wearable devices like the Embrace Nest incubator for preterm infants.

At IIDiA, we see a future where no mother or child is left behind. These tools prove that localized digital solutions can turn survival into thriving, saving time, lives, and hope.

### Spotlight: Ghana's Payment Interoperability - A Blueprint for Africa



Ghana has made history as Africa's only fully interoperable payments market, seamlessly linking mobile wallets, bank accounts, and merchant payments.

#### Key milestones:

- ✓ Mobile-to-Bank Transfers: No intermediaries needed (powered by GhIPSS since 2018)
- ✓ Universal QR Payments: One code works across all providers
- ✓ Cost Reduction: Lower fees boost SME adoption

This model proves that collaboration > competition in financial inclusion. With 75% of adults now using mobile money (KPMG 2024), Ghana offers a replicable playbook for:

- Governments crafting cashless policies
- Fintechs scaling cross-platform solutions
- Telcos expanding rural access

# Breaking Barriers: Benin Launches West Africa's First Fon-Language Al



In a historic leap for digital sovereignty, IIDIA and Benin's ASIN, with support from the Gates Foundation have unveiled the Regional Innovation and Digital Technology Lab in Cotonou, with its flagship project: the first voice AI model for the Fon language.

This innovation tackles a critical exclusion factor, 85% of Benin's rural population speaks Fon but lacks nativelanguage digital tools.

Three Life-Changing Use Cases:

Locating emergency pharmacies

Voice-based mobile money balance checks (partnering with Celtis)

Simplified birth certificate procedures



The world marked the 10th anniversary of World Youth Skills Day on 15<sup>th</sup> July 2025, the focus sharpens on a critical mission: equipping young people with the digital and artificial intelligence (AI) skills essential for success in a rapidly transforming global economy.

The 2025 theme, "Youth Empowerment through Al and Digital Skills," captures both the promise of innovation and the stark reality of a persistent digital divide, one that risks leaving millions of African youth on the sidelines of the digital revolution.

A typical example is found in Benin, where a voice AI project in the Fon language, a first for West Africa, demonstrates how linguistic inclusion can unlock digital participation for millions. 
Tazama, offering real-time insights into transaction-level activities, will enables early detection and rapid response to fraud and scam attempts across national and institution payment platforms, equipping countries and financial institutions like banks and mobile money operators with critical infrastructure to protect users and strengthen trust in digital finance.

IIDIA will lead the regional rollout of Tazama's tools across Africa. Leveraging its pan-African policy expertise, research network, and partnerships with governments and central banks, IIDIA will ensure that Tazama's tools are localized, scalable, and aligned with national digital transformation agendas.
